**RESOLUTION OF THE PLAINFIELD MUNICIPAL UTILITIES AUTHORITY
RATIFYING A COLLECTIVE NEGOTIATIONS AGREEMENT WITH
TEAMSTERS LOCAL 97**

WHEREAS, the Plainfield Municipal Utilities Authority ("Authority") is a public body corporate and politic of the State of New Jersey, duly created by the City of Plainfield pursuant to Ordinance MC-1995-19 and in accordance with the Municipal and County Utilities Authorities Law, N.J.S.A. 40:14B-1 et seq., and authorized to provide certain solid waste and sewerage services to the inhabitants of the City of Plainfield; and

WHEREAS, the Authority engaged in negotiations with Teamsters Local 97 as to the terms and conditions of employment for all regularly employed, non-supervisory, full and part-time, blue collar employees of the Authority ("Covered Employees"); and

WHEREAS, the Authority and Teamsters Local 97 reached an agreement covering the period from January 1, 2011 through December 31, 2015; and

WHEREAS, the Authority desires to ratify the Collective Negotiations Agreement in order to establish the terms and conditions of employment for all Covered Employees; and

WHEREAS, the Collective Negotiations Agreement, attached hereto and incorporated herein, is deemed to be fair and equitable, and the Authority desires to ratify the Collective Negotiations Agreement in the best interests of the Authority and the citizens of the City of Plainfield;

NOW, THEREFORE, BE IT RESOLVED by the Plainfield Municipal Utilities Authority as follows:

1. The Board of Commissioners of the Plainfield Municipal Utilities Authority hereby ratifies the Collective Negotiations Agreement with Teamsters Local 97, establishing the terms and conditions of employment for all Covered Employees for the period from January 1, 2011 through December 31, 2015.

2. A copy of this resolution shall be maintained in the offices of the Authority and made available for public inspection.

3. This Resolution shall take effect immediately.
