NOTICE OF JOINT BOARD MEETING VIA ELECTRONIC AND TELEPHONIC PLATFORM

PLEASE NOTE the Committee Meeting of the Plainfield Municipal Utilities Authority (the "Authority"), originally scheduled for Thursday, September 10, 2020 at 6:00 p.m., at the Authority's offices located at 127 Roosevelt Avenue, Plainfield, New Jersey, has been rescheduled to Tuesday, September 15, 2020, at 6:00 p.m. The rescheduled Committee Meeting will be held in conjunction with the Authority's Regular Meeting; and will not physically take place at the Authority's offices, and will be open to the public by electronic means through a teleconference via Turbo Meeting and telephonically in order to comply with the State of Emergency declared by Governor Murphy on March 9, 2020, Executive Order No. 107 issued on March 21, 2020, and Executive Order No. 180 issued on August 27, 2020 in response to Covid-19, and subsequent guidance from the Division of Local Government Services in the Department of Community Affairs for conducting remote public meetings. Executive Order No. 180 extended the public health emergency initially declared in Executive Order No. 103 due to Covid-19 and continues in effect the requirements in Executive Order No. 107 that all New Jersey citizens continue to practice social distancing and Executive Order No. 163 that face coverings should be worn indoors and all circumstances where it is not possible to practice social distancing while outdoors.

In accordance with the procedures governing in-person meetings, members of the public will only be permitted to speak during the public hearing portion of the meeting.
